## LETCHER CO AMATEUR RADIO CLUB

The Letcher County Amateur Radio Club was formed in 2008. Founding members included Tim Webb - KK4WH, Terry Richardson -K4KYM, Chris Rife - N4QBE and others. The club operates the KM4IAL repeater located atop Pine Mountain, the second highest mountain in Kentucky outside of Whitesburg. Repeater frequency is 145.350 - offset PL Tone 186.2. The club holds several events throughout the year. One of the signature events is providing communications for the Cloud Splitter 100 race. Which is a 100 mile and 100K mountain terrain foot race, which is held in the first of October. Racers begin in Elkhorn City in Pike County and race to Letcher County and then back to Elkhorn City. The club along with Hams in Pike County checks runner in and out at various points along the race to ensure all racers have a safe and enjoyable time.

## **FEMA /ARES**

For several months now there has been articles written in regards to requirements with local EMA groups in our counties and what may be the requirements going forward in Kentucky. With the formal MOU agreement with FEMA and ARRL in 2014 expectations were expected of both parties.

Kentucky will have a 2 Tier system. One, members who wish continue in ARES with Red Cross and local civic organization may continue as they have in the past. No additional requirements will be expected, unless specific request are made directly from a served agency, i.e Red Cross.

However, with the above mention MOU, things will moving in a different direction in regards to FEMA and state sponsored EMA groups. In order to work directly with EMA / FEMA it is expected that each person has completed the basic coursework in regards IS 100 200 700 and 800. Those that choose to work closer with management and the incident command system will be required to take other course work such as IS 300 400 level courses. I would encourage everyone that is interested in this topic to read the formal MOU at <u>FEMA / ARRL MOU</u>

In the Fall, we hope to have an ARES conference to introduce many items that will be coming, our partners, and the different methods that will used to provide the request that will be made upon us. The training curve will interesting .

Many think the League is pushing this endeavor but actually FEMA is moving the bus. The beta testing going on this year in regards to reporting and the new data base with ARRL is tied this program. Your participation hours are very meaningful for your local EMA program that helps fund future grants that may be submitted. Stay tuned as progress this road together.

As for me, not much to report from my end in February, got my shack cleaned up and operated a little FT8 and chased some DX. I'll be on the road a little more this summer, so I'm starting to look at VHF/UHF mobile options for my car. So many choices these days, I'll have a hard time deciding. I think I'll take the plunge (literally) and drill proper NMO mounts into my trunk lid instead of messing about with lip mount brackets this time.

For April, I thought about making the ham fest E-town, but I have to be in Frankfort that same morning, so I'll have to settle for waving as I drive by this year.

My two technical tidbits for the month:

1. I was chasing a problem with static discharge on my K-Pod (it's basically a remote VFO for the Elecraft K3.) I keep it on my operating desk just to the right of the shack computer mouse. I noticed when I walked over to the desk and grabbed the mouse, the K-Pod would beep. Further investigation showed I was getting static electricity discharge from my finger through the K-Pod, and one particular morning I even noticed an arc from my little finger to the K-Pod case. Obviously, I didn't want static electricity discharging through my K-Pod and then through my K3. So, I wrote the Elecraft discussion group for ideas on how to mitigate the static problem. I was thinking some sort of grounded mouse/keyboard mat, or bonding the K-Pod to the shack ground, but the ultimate solution proved much simpler. I was describing the problem to my wife and she said, "Why don't you just move the humidifier from the nursery into your office for a while to see if that helps?" Yep. It worked. Sometimes it's the simple things.

2. OpenSpot hotspots are now reporting their location into the APRS network. A neat feature, but not necessarily for those who did not choose to opt in for this service. I did not, but see the attached screenshot of my home QTH. I never allowed this, it just happened. I expect there may be some backlash from privacy-minded hams who don't necessarily want to show up on the APRS maps. Again, I think this is a neat feature, but it is a case where people should have the option to opt in...and opt out!
